Our 10-year battle ...

- 500.000+ Survivors in Europe with an increased risk of developing health problems (late effects)
- Many survivors are unaware of their risk for specific late effects
 - Reduces their ability to manage their own follow-up care
- In addition, many healthcare professionals lack information about the required care for survivors:
 - Have no access to treatment data from their childhood cancer
 - Clinical guidelines tell healthcare professionals what care is needed
 - It's challenging to put them into practice
- What should we do about this?

What is the Survivorship Passport? Will it solve the problem?



- A tool, that automatically suggests follow-up examinations
 - Depending on the underlying disease and therapy received
 - At appropriate time
 - Depending on relevance
- This will give us the opportunity to manage our own health and receive adequate medical care
 - Whether at home or abroad
- Healthcare professionals will know what will be needed and when
 - to help us to have the best possible quality of life
- It also means, that we don't have to keep telling our whole story again and again
 - That will the Survivorship Passport do for us



PanCareSurPass

Our overall aim is to leverage the digital transformation of healthcare to improve person-centred care for survivors of childhood and adolescent cancer by scaling up and implementing an interoperable Survivorship Passport (SurPass) v2.0 across Europe.




What is the PanCareSurPass project?



• EU-funded project

- Looking for the best way to implement more widely the SurPass to improve survivorship care in Europe
- Developing an implementation strategy for different countries, considering all possible challenges
- Develop, Test and launch a digital SurPass version
 - Translations in German, French, Italian, Lithuanian and Spanish










Where will the SurPass be implemented?





Survivorship Passport

Clinics in Austria, Belgium, Germany, Italy, Lithuania and Spain will implement the digital Survivorship Passport into their Electronic Health Information Systems to improve person-centred care for survivors of childhood and adolescent cancer.





What will happen in this project?





- A multi-country implementation study, looking at survivor empowerment, satisfaction with the tool
- Develop materials for an easier implementation of the digital SurPass in whole Europe in the future
- Disseminate and communicate our research so survivors and their families, healthcare professionals, decision and policy makers


